## SchoolKidz™ 2023 Marketing Contest

## **Official Contest Rules**

NO PURCHASE NECESSARY. Participation constitutes participant's ("Participant") full and unconditional agreement to and acceptance of these Official Contest Rules. Void in Rhode Island.
